If ever there was a time to truly value the essential service performed by child care providers, it is now.


In 2019, which this Annual Report details, Programs for Parents made real strides towards making New Jersey's child care industry better educated, understood and represented. We also continued to help parents be better informed and equipped to address the pressing needs of young children in their communities.

In 2019, under the auspices of Programs for Parents, the Essex County Council for Young Children (ECCYC) was selected as one of ten national coalitions to receive funding from the Boston Medical Center/Network of Opportunity for Child Wellbeing. This national initiative seeks to address adverse childhood experiences (ACEs) and trauma in the early care and education community. With this funding, PfP achieved three important goals. First, we educated providers on childhood trauma and adverse childhood experiences through a series of educational programs. Next, we trained providers and parents on how they can ensure that young children have positive social emotional experiences. Finally, we equipped families with the knowledge and tools they need to easily access community resources when trauma occurs.

Programs for Parents is also proud to have played a key role in taking the concept of shared services statewide in 2019. Having pioneered the concept of shared services in the childcare industry with the Greater Newark Shared Services Alliance, the agency was asked to host information-sharing conferences across the state. The shared services concept is one of the most exciting and progressive developments in the child care industry today. By banding together, early childhood educators can save vital time and money, freeing them to undertake efforts to improve the quality and efficiency of their programs.

This past year was also special because Programs for Parents celebrated its 35th anniversary. To mark this milestone, we were invited to ring both the opening and closing bells on the New York Stock Exchange. It was a great honor and a symbolic one. It was a reminder of how much work remains to be done to bring the business community to a true appreciation of the vital connection between a productive workforce and accessible quality child care.



# PfP Celebrates a Milestone 35th Anniversary

rograms for Parents celebrated its 35th anniversary through a number of programs and special events. Chief among them was ringing the bell that opened the New York Stock Exchange by PfP CEO Dr. Beverly Lynn, who was accompanied by staff, board members, child care providers and parents. "While today is a day of celebration, it is also symbolic of the need for the business industry to participate in discussions that support working families," said Dr. Lynn. "Child care is, after all, everybody's business." A special commemorative 35th anniversary video was made and displayed at PfP's Annual Meeting in June. On that occasion, PfP received a letter from Senator Bob Menendez recognizing the outstanding work that Programs for Parents has provided to the families of Essex County for the past 35 years.

# Greater Newark Shared Services Alliance Goes Statewide

hared Services is among the most exciting and progressive developments in the child care industry today and once again Programs for Parents was at the forefront. Having successfully launched the first shared services initiative for child care providers in New Jersey, Programs for Parents was asked to facilitate a statewide



conference on the concept. The goal was to educate and inspire communities to launch shared services initiatives in their communities. The conference took place in February and was attended by child care providers, funders, child care resource and referral agencies and other stakeholders.

Now in its third year at Programs for Parents, the Greater Newark Shared Services Alliance (GNSSA) continues to be a tremendous success, saving child care providers thousands of dollars in expenses, time and by providing a pool of qualified substitute teachers. Currently, GNSSA is working toward piloting a centralized data management system that simplifies scheduling and attendance tracking, collects payments, securely stores data, and provides a platform to engage families.











# Adverse Childhood Experiences (ACEs) and Trauma

s noted previously, the Essex County Council for Young Children (ECCYC) was selected as one of ten national coalitions to receive funding from the Boston Medical Center/Network of Opportunity for Child Wellbeing. The ultimate goal of this effort is for the City of Newark to be a Trauma Informed Care Community by the end of 2020. To achieve that, ECCYC has offered monthly webinars, the first of which was led by Dr. Renee Boynton Jarrett, a pre-eminent leader on the topic. She spoke on the "Impact of Trauma on Children" in April. The following month, Dr. Dale Caldwell, another thought leader on the subject, spoke on "Urban Traumatic Stress Disorder." PfP has three goals for this work: (1) educate the Early Care and Education community about childhood trauma and adverse childhood experiences (ACEs) through workshops, webinars, focus groups, and community gatherings, (2) ensure that young children have positive social emotional experiences that help them to be resilient in the face of trauma, and 3) when traumatic experiences occur, ensure that families are aware of community services and that they are easy to find.

# Family Child Care Providers Receive Needed Quality Improvement Grants

or Family Child Care Providers, a major highlight in 2019 was the opportunity to receive a \$2,000 Health and Safety Grant provided by the Department of Human Services, Division of Family Development. Intended to improve the quality of care provided, these grants were used for a wide range of needs, including to: abate health and safety violations; obtain emergency preparedness kits; purchase educational materials and supplies; purchase liability insurance; make small repairs; attend professional development events; and purchase a computer. Over 50 Family Child Care Providers applied and more than \$65,000 in grants were awarded.




# PfP to Provide Quality Care to Newark's South Ward Children



rograms for Parents helped unlock the potential of children in Newark's South Ward neighborhood in 2019 with funds from a \$30 million Promise Neighborhood grant received by the South Ward Children's Alliance. After conferring with part-

ners and community leaders on how best to support families in the South Ward, Programs for Parents launched a CDA (Child Development Associate) training class in the neighborhood. (The CDA credential is the most widely recognized credential in early childhood education. It signifies that the individual is knowledgeable and competent to help children move from one developmental stage to the other.) Twenty early childhood caregivers who live or work in the South Ward Promise Neighborhood participated. Because of the grant, all course fees were covered and the class was provided at a South Ward location to make it convenient for the participants. Increasing the care giving skills of teachers who work in early childhood programs will improve the quality of early care and education for young children in the South Ward.
